

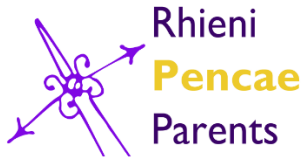

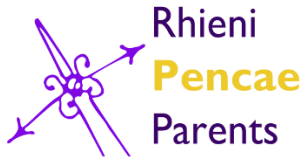

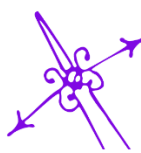
7. Unrhyw fater arall

raised with the notifications. Catrin advised that notifications from Classlist can be turned off and that take up of Classlist to date has been good. Catrin and Mari stated that the PTA needs to have a system in place in order to do things in a data compliant way and in accordance with the General Data Protection Regulation, hence the adoption of Classlist.

7. Other business

- Mr Thomas gently reminded parents to use WhatsApp sensibly and never to refer to members of staff in any way inappropriately. Mr Thomas stated that he has in the past, and will in the future if necessary, summon parents into school if he is made aware of inappropriate comments on WhatsApp and Classlist.
- Julie raised a concern about the inconsiderate and dangerous parking near the school. Action: Mr Thomas stated that there will be a 20 mph zone in Highfields from December and the Council parking enforcement team will be visiting the area in the near future.
- Thomas, a Parent-Governor has noted that he will be bringing his proposal for a school bus to a future PTA meeting. Action: Proposal to be presented to PTA for proper consideration
